




This is your first momentus step in becoming an awakened citizen

What are social movements?

Social movements emerge when groups of citizens join together to respond to failures by government and other power holders


Social movements become activated around an important underlying value that is widely shared in the community

They take action to expose the failure of power holders to respect that value and they work to promote that value in the public sphere

The Life Cycle of Social Change

- Social movements are like other living things, the movement and the people in and around it go through cycles of change
- · these include:
 - eight stages of a successful social movement
 - · the four roles of awakened citizens,
- Author Bill Moyer presents a theoretical map of the stages of a successful social movement

The eight stages of social movements



The Life Cycle of the Awakened Citizen

As individuals become awakened and active citizens their world view and experiences begin to change and develop
As they experience the backlash from powerholders and vested interests that they are questioning then they begin to see more deeply the lies, greed and often corruption that lies behind the issue they dared to question

This often ignites a personal and political outrage in the person and they commit themsleves to working to change those underlying conditions as well as work on the issue that got them started

Growth and change

As individuals work in a social movement setting they often adopt particular roles, sometimes simply as the awakened citizen, sometimes for a while as an angry rebel, and often they also develop a deeper set of social change skills over the years and learn to work effectively as change agents and reformers

Moyer explains these terms more in his book "Doing Democracy"

The four typical activist roles





Reformer

All four roles must be played effectively in a successful social movement (Moyer 2001)

Citizen

Rebel

Change agent





What is special about the CSG campaign?



So what can you do about CSG?

Concerned citizens magnify their power and political impact when they take part in broader social movements

You can get together with friends and neighbours, start new groups or join existing groups committed to fighting the scourge of csg and other mining impacts in your communities

Individual Activity

Individual actions, like locking your gate matter, but they are much more powerful when done in solidarity with your community



The CSG-free community strategy

- A new and powerful tactic for CSG is the idea of creating no-go areas enforced by community action
- Its an extension of lock the gate beyond the property boundary to the public sphere
- First agree with neighbours to lock your road, then your valley, community, shire
- · Ultimately: a CSG free community!

- On the website you can find templates and instructions for holding your first public meetings, collecting the views of neighbours, establishing road committees and decalring yourselves csg free

What will be required of us?

Once your community has decided to go csg free you will need to internally organise yourselves to watch over your patch you will need phone trees to help with alerting each other to incursions by mining companies

You will need to meet and discuss your community's action plans

Be Watchful

A key ingredient is community vigilance, keeping an eye out and alerting each other about what you see.

real defence is like a cross between neighbourhood watch and the rural bushfire brigade.



Get Ready to Hold Your Roads Your community, with the help of your surrounding community and the wider social movement may need to consider the use of civil dispobedience and non violent direct action to prevent mining activity this is made necessarry becuase of the failure of parliament and politicians to have stood up to the power of the mining corporations

What is Direct Action?

- Protest activity that 'directly' engages with the the issue or problem
- usually direct in the sense of physical, practical to prevent or delay an activity or to make a powerful statement
- · Does not usually require large
- numbers
- · Must communicate a clear message
- · Direct actions often theatrical and visual





- Only requires small group of activists
- Fun
- Easy and cheap to organise
- · Original and interesting to media and public
- · Visible, pertinent and clear messages
- BUT: may involve minor breaches of the law, and require lots of courage and cheek.

The Importance of Non-Violence

- Non-Violence is an essential pre-condition to any discussion about activism, direct action, protest, both philosophically and practically
- We should distinguish between intended violence and sporadic unintended outbursts
- Outbreaks of sporadic violence are often associated with policing practices
- Media will distort violence



Civil Disobedience

- The courts will not allow anyone to break the law but they have discretion over sentencing and can discharge without penalty or record (NSW s 10 Crimes Act)
- At the very least an intentional law breaker has a right to break the law and to be arrested and processed according to law for doing so
- Conscientious objection is different to crime, there is no dishonesty, and no attempt to evade the legal consequences

The Role of Police and Police Liaison

- Police liaison is essential to maintain respectful and cordial relations with police:
 - it is about communication not control
 - you should aim to talk to police to establish what are arrestable and non arrestable activities
 - Explain that law breakers have a right to due process
 - Be polite, firm and direct with police
- This is a complex area but The Activists Handbook should help you understand this area better

The Theory of Change

Our politicians and parliaments have failed to provide the community wioth adequate protection from the risks associasted with widespread coal seam gas mining and other types of mining to the point where mining companies have an almost carte blanch power to enter properties and cause damage

Communities are resisting this. Every time a community resists non-violently they succeed in proving that there is no social license or consent for this invasion of communities Inevitably the political costs for the politicans and for the companies themselves will build until a political solution is unavoidable Community resistance on a grand scale is all that can save us now

United Action and the Long Haul

We cannot expect this campaign to be fast or easy. the billions of dollars that mining companies seek to extract will make them very determined to go ahead regardless of the social environmental or other costs politicians will not back down easily Communities should expect to lose many battles along the way, but it is the sheer perseverence of communities that will win this

Resilience

The final chapter of the Activists handbook provides insights on how individuals and groups can esnure their long term emotional physical and mental well being whilst engaging in the fight for their lives. make sure you read this and take heed

Remember the Successful Social Movements and the perseverance that was needed.

Perseverence of social movements is what makes them suceed against all odds polticians and companies work on short cycles of profit return and elections and cannot endure a sustained and widespread community campaign remember:

The campaign to get the vote for women, for an end to slavery, and to exit the vietnam war
